

# Your Information. Your Rights. Our Responsibilities.

This notice describes how medical information about you may be used and disclosed and how you can get access to this information.

Please review it carefully.

When it comes to your rights and some of our res	health information, you have certain rights. This section explains your sponsibilities to help you.
Get an electronic or paper copy of your medical record	<ul> <li>You can ask to see or get an electronic or paper copy of your medical record and other health information we have about you. Ask us how to do this.</li> <li>We will provide a copy or a summary of your health information, usually within 30 days of your request. We may charge a reasonable, cost-based fee.</li> </ul>
Ask us to correct your medical record	<ul> <li>You can ask us to correct health information about you that you think is incorrect or incomplete. Ask us how to do this.</li> </ul>
	<ul> <li>We may say "no" to your request, but we'll tell you why in writing within 60 days.</li> </ul>
Request confidential communications	<ul> <li>You can ask us to contact you in a specific way (for example, home or office phone) or to send mail to a different address.</li> <li>We will say "yes" to all reasonable requests.</li> </ul>
Mobile SMS Privacy Policy	<ul> <li>Messaging Terms &amp; Conditions. You agree to receive informational messages (appointment reminders, account notifications, etc.) from Rewired Canvas Psychotherapy, LLC. Message frequency varies. Message and data rates may apply. For help, reply HELP or email us at info@rewiredcanvas.com. You can opt out at any time by replying STOP.</li> </ul>
	<ul> <li>Information Collected: We may collect information such as name, phone number, and email address.</li> </ul>
	• Use of Information Collected: We may use the information we collect to perform the services requested including billing, customer service,
	appointment reminders, and other administrative requests. <ul> <li>Sharing of information collected: We may share information we collect</li> </ul>
	with payment processors, legal authorities, partners so that these service

(Mobile SMS Privacy Policy cont'd)	providers can perform their normal duties. We do not share, sell, rent, or trade any information provided with third parties for promotional purposes. Your mobile information will not be shared with any third parties/affiliates for marketing/promotional purposes. All policies are followed as per CTIA guidelines 5.2.1. At any time if you want your information to be removed, you can contact us via our email address or regular mail.	
Ask us to limit what we use or share	<ul> <li>You can ask us <b>not</b> to use or share certain health information for treatment, payment, or our operations.</li> <li>We are not required to agree to your request, and we may say "no" if it</li> </ul>	
	would affect your care.	
	<ul> <li>If you pay for a service or health care item out-of-pocket in full, you can ask us not to share that information for the purpose of payment or our operations with your health insurer.</li> </ul>	
	<ul> <li>We will say "yes" unless a law requires us to share that information.</li> </ul>	
Get a list of those with whom we've shared information	<ul> <li>You can ask for a list (accounting) of the times we've shared your health information for six years prior to the date you ask, who we shared it with, and why.</li> </ul>	
	• We will include all the disclosures except for those about treatment, payment, and health care operations, and certain other disclosures (such as any you asked us to make). We'll provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.	
Get a copy of this privacy notice	• You can ask for a paper copy of this notice at any time, even if you have agreed to receive the notice electronically. We will provide you with a paper copy promptly.	
Choose someone to act for you	<ul> <li>If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your health information.</li> </ul>	
	<ul> <li>We will make sure the person has this authority and can act for you before we take any action.</li> </ul>	
File a complaint if you feel your rights are violated	<ul> <li>You can complain if you feel we have violated your rights by contacting us using the information on page 1.</li> </ul>	
	<ul> <li>You can file a complaint with the U.S. Department of Health and Human Services Office for Civil Rights by sending a letter to 200 Independence Avenue, S.W., Washington, D.C. 20201, calling 1-877-696-6775, or visiting www.hhs.gov/ocr/privacy/hipaa/complaints/.</li> <li>We will not retaliate against you for filing a complaint.</li> </ul>	

For certain health information, you can tell us your choices about what we share. If you have a clear preference for how we share your information in the situations described below, talk to us. Tell us what you want us to do, and we will follow your instructions.

In these cases, you have both the right and choice to tell us to:	<ul> <li>Share information with your family, close friends, or others involved in your care</li> </ul>
	<ul> <li>Share information in a disaster relief situation</li> </ul>
	<ul> <li>Include your information in a hospital directory</li> </ul>
	• (Rewired Canvas does not maintain a directory of client information for use as general information. Client information will be stored in an electronic health record. Any acknowledgement of a client's participation in services will be made in compliance with laws and regulations pursuant to HIPAA and 42CFR Part 2).
	Contact you for fundraising efforts
	If you are not able to tell us your preference, for example if you are unconscious, we may go ahead and share your information if we believe it is in your best interest. We may also share your information when needed to lessen a serious and imminent threat to health or safety.
In these cases we <i>never</i> share your information unless you give us written permission:	<ul> <li>Marketing purposes</li> <li>Sale of your information</li> <li>Most sharing of psychotherapy notes</li> </ul>
In the case of fundraising:	<ul> <li>We may contact you for fundraising efforts, but you can tell us not to contact you again.</li> </ul>

Rewired Canvas Psychotherapy will not contact clients for fundraising efforts.

## Our Uses and Disclosures

How do we typically use or share your health information? We typically use or share your health information in the following ways.

Treat you	<ul> <li>We can use your health information and share it with other professionals who are treating you.</li> </ul>	<b>Example:</b> A doctor treating you for an injury asks another doctor about your overall health condition.
Run our organization	<ul> <li>We can use and share your health information to run our practice, improve your care, and contact you when necessary.</li> </ul>	<b>Example:</b> We use health information about you to manage your treatment and services.
Bill for your services	<ul> <li>We can use and share your health information to bill and get payment from health plans or other entities.</li> </ul>	<b>Example:</b> We give information about you to your health insurance plan so it will pay for your services.

**How else can we use or share your health information?** We are allowed or required to share your information in other ways – usually in ways that contribute to the public good, such as public health and research. We have to meet many conditions in the law before we can share your information for these purposes. For more information see: www.hhs.gov/ocr/privacy/hipaa/understanding/consumers/index.html.

Help with public health and safety issues	<ul> <li>We can share health information about you for certain situations such as:</li> <li>Preventing disease</li> <li>Helping with product recalls</li> <li>Reporting adverse reactions to medications</li> <li>Reporting suspected abuse, neglect, or domestic violence</li> <li>Preventing or reducing a serious threat to anyone's health or safety</li> </ul>
Do research	• We can use or share your information for health research.
	<ul> <li>In the event of any research, clients will be notified about their rights to choose to participate and will be provided with an opportunity for informed consent. Clients and their information will not be used or disclosed without prior consent.</li> </ul>
Comply with the law	<ul> <li>We will share information about you if state or federal laws require it, including with the Department of Health and Human Services if it wants to see that we're complying with federal privacy law.</li> </ul>
	<ul> <li>Rewired Canvas Psychotherapy will never share any substance abuse treatment records without your written permission.</li> </ul>
Respond to organ and tissue donation requests	<ul> <li>We can share health information about you with organ procurement organizations.</li> </ul>
	<ul> <li>Rewired Canvas Psychotherapy will not provide or disclose any information without prior authorization or disclosure to medical professionals. Rewired Canvas Psychotherapy will not ask you about your preferences for organ donation.</li> </ul>
Work with a medical examiner or funeral director	<ul> <li>We can share health information with a coroner, medical examiner, or funeral director when an individual dies.</li> </ul>
Address workers' compensation, law enforcement, and other government requests	<ul> <li>We can use or share health information about you:</li> <li>For workers' compensation claims</li> <li>For law enforcement purposes or with a law enforcement official</li> <li>With health oversight agencies for activities authorized by law</li> <li>For special government functions such as military, national security, and presidential protective services</li> </ul>
Respond to lawsuits and legal actions	<ul> <li>We can share health information about you in response to a court or administrative order, or in response to a subpoena.</li> </ul>
	• In the event any client of Rewired Canvas Psychotherapy has any legal issues or pending court appearances, prior discussion about participation or disclosure of information will be required. In the event participation in court cases is requested, (e.g., via a written letter, therapeutic opinion, or presence in court), additional required fees will be discussed. Rewired Canvas Psychotherapy will not participate in any legal or court proceedings pertaining solely to client's or client's family legal issues without consulting legal representation. Full disclosure about legal involvement that affects or might affect psychotherapy services is requested.

### **Our Responsibilities**

- We are required by law to maintain the privacy and security of your protected health information.
- We will let you know promptly if a breach occurs that may have compromised the privacy or security of your information.
- · We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or share your information other than as described here unless you tell us we can in writing. If you tell us we can, you may change your mind at any time. Let us know in writing if you change your mind.
